## **Entry Fee:**

**Youth Events (3 Bird) \$ 50.00 per dog for members and \$ 80.00 per dog for non-members;**

**Non-Doubles Events (3 Bird) \$65.00 per dog for members and \$ 90.00 per dog for non-members;**

**Pointing Doubles Division (5 Birds) - \$ 60.00 per dog for members and \$ 85.00 per dog for non-members;**

**Flushing Doubles Division (5 Birds) - \$ 60.00 per dog for members and \$ 85.00 per dog for non-members.**

1. You will note there are five (5) divisions in each category; see above. Please refer to the rules for each division you wish to run. Rules are posted on the website: [www.RMtSDC.com/Entry Forms and Rules](http://www.RMtSDC.com/Entry Forms and Rules)
2. Youth (age 10-17) must have a hunter safety card. Youth (10-13) parent must accompany them in field as they run.
3. You may run multiple dogs in each division and/or in the different divisions. Dogs may only run for one qualifying score in each division. They may run additional times as a bye dog.
4. Entries may be made on the website and payment with credit card using our Pay Pal shopping cart. You may elect to download entry form, fill out and email to [huntsmartpro@gmail.com](mailto:huntsmartpro@gmail.com). Payment can be made by cash or check the day of the trial or online at [RMTSDC.com/entry forms and rules](http://RMTSDC.com/entry forms and rules). **Cancellations received 5 days or less prior to the trial, entrant is responsible for the full payment for divisions which they entered.**
5. No checks will be deposited until after the trial. All non-member entrants must sign a liability waiver and bring it with them to the trial. Liability waiver can be downloaded off our web site, [www.RMTSDC.com](http://www.RMTSDC.com)
6. Registrations will close the Wednesday before the trial. All entries will be handled on a first come, first served basis.
7. There will be two fields. Field assignments will be based on the number of entries per category. Prizes will be awarded and photos taken for 1st, 2nd, and 3rd place finishers in each division. **Please stay for your photos so that we can post them on the website!**
8. The trial will start promptly at 8 AM, prior to March 1<sup>st</sup> trials start promptly at 7:30 AM.

**The top three finishers of each trial will automatically qualify for the semifinals of the Club Championship to be held at season's end.**

**The top three finishers in both Open & Double's Divisions earn points toward "Dog of the Year" in flushing and pointing categories. The top three finishers in Novice Divisions earn points towards "Novice Dog of the Year" in flushing and pointing categories.**
